## PMCPOA 2016 ELECTION COMMITTEE DRAFT MINUTES February 29, 2016

As a candidate for the Board of Directors I must agree to comply with the following:

- 1. I shall attempt to attend all training and orientation sessions scheduled for Board members. Commitment Pledge #19m Appendix H.
- 2. I will not place campaign signs on PMC property. (EC Code)
- 3. I will not place campaign signs on private property without the permission of the owners or violate EC Code requirements (25 feet from road center) for placement of signs on private property. (EC Code)
- 4. Signs placed on Mil Potrero Hwy. will comply with Kern County Code (55 feet from road center). (Kern County Code)
- 5. I understand that all unauthorized signs will be removed. (EC Code)
- 6. All campaign signs will be restricted to a maximum of 12 inches by 18 inches.
- 7. No signs shall be placed prior to April 9th and will be collected the day after the Election.
